

From the President-Elect Steve Pecevich, MD

Early in spring 2020, at the height of the initial pandemic panic, I had the unfortunate experience of being diagnosed with Hodgkin lymphoma. One day you're navigating 12-hour shifts, trying to explain who warrants a test, what to do if patients feel sick, trying to work with infectious disease staff about how to organize the ED for a COVID surge, etc. Then one night after a long day, you feel a painless racquetball lump in your supraclavicular fossa and immediately flash back to those Step 1 days. I restarted my shifts in July 2020 while on treatment. Perhaps a reckless decision pre-vaccine, but I missed my team and our community needed help. I won't lie. It was scary. N95 on at all times, chugged water in the bathroom, then back to patients. I finished my 6 months of chemo and I'm clear now.

Please forgive the humble brag, but I completed an Ironman 70.3 in Boulder, CO this past weekend. It was my first triathlon, and it was not only extraordinarily challenging, but also a blast to finish. Of note, I witnessed and then helped with a crash during the ride. Some people's behaviors that day, however, has been bugging me a bit. About a quarter mile ahead of me on a descent, a rider must have gone over the handlebars, easily 20-30 mph at minimum. I watched multiple riders slowly pass by the racer, essentially ignore the individual, and continue pedaling. This individual had, at minimum, a significant

concussion, a likely facial fracture and several other areas of trauma and bleeding. Canadian and Nexus need not apply.

Fortunately, a support motorcycle approached us after about five minutes and radioed an ambulance. I'll admit that I carried some disdain for the people who essentially ignored us. Were race times really that important? Was it such a big deal to slow down for five minutes and check on a crash? To keep someone company? Then again, they probably could not offer much. And I'm starting to accept that more. If not us, as EM clinicians, then who else? Sure enough, about 15 miles later, a similar situation ensued with another ravine victim, but luckily much less severe. I told the rider in front of me, "On your right!" He barked, "You can't pass on the right! That's a penalty!" (No water bottles were thrown).

Yawn. Alright, Steve, get to the point. I didn't race for cancer or any specific reason, really. Perhaps just masochism and my friends were doing it. People have asked me if I have a specific charity or pledge where they can donate for my race. I'm not a cancer mascot. Instead, I've politely asked that they convince a loved one, or really anyone, to get vaccinated.

I think my ultimate conclusion is that the race brings quite a bit of tension, and furthermore, these are tense times. We all know we don't make a dime to counsel a patient to reconsider their hesitancy, misinformation, or complete distrust of the vaccine. None of us had a conversation during a residency interview about our excitement to have vaccine discussions with patients. All I ask of you all as EM clinicians is five minutes. Set a timer. Have your charge nurse grab you. Get a call from your tech. But please give five legitimate minutes while sitting down, making eye contact, and being empathetic to someone's concerns. We went into this to save lives. This vaccine saves lives. Don't ignore someone's crash.


