

Update from ACEP21

Rural America was up front and center at this year's National ACEP Council meeting. Given the 2021 workforce report ([https://www.annemergmed.com/article/S0196-0644\(21\)00439-X/fulltext](https://www.annemergmed.com/article/S0196-0644(21)00439-X/fulltext)) which predicts an excess of 7,000 trained emergency medicine physicians by 2030, this is a major issue. It is a major issue playing out actively in Wyoming as well as many other rural states. One of the core issues that ACEP is trying to address is the workforce issues. There were many different viewpoints expressed during the Council, varying from having only emergency medicine trained physicians in all departments, trying to supervise all advanced practice practitioners, to finally working on getting hard data for how rural emergency departments are staffed and their volumes. The College was split as to only supporting emergency medicine residency trained physicians versus focusing on emergency medicine residency trained physicians as team leaders and medical directors. We shall see how future data plays out.

Current ACEP Framework of Workforce Consideration

- Define EM residency standards: raising the bar for patients.
- Ensure business interests do not supersede need of educating the workforce.
- Protect the unique role of emergency physicians.
- Support emergency physicians in all communities, especially rural.
- Increase demand for emergency physician services to meet the evolving community need.

Beyond just the workforce many other concerns were discussed. We spoke about the [Strategic Plan for ACEP](#). Currently there are work groups addressing advocacy, career fulfillment, communication, member engagement, new practice models, personalization of services, resources, and trust. **I give the question back to you - what are you wanting from ACEP? What can Wyoming ACEP do for you?** One other issue that was brought forth was potentially combining the small chapters resources to make the most financial sense. **What are your thoughts on combining our chapter with other small chapters?**

Some of my final thoughts are how to get back to ACEP roots on how to protect our specialty. What are your opinions on addressing the COVID crisis, burnout, workforce, addressing concerns of new-career, mid-career and late-career physicians? I feel the guiding light of ACEP should always be how to best take care of patients and the emergency medicine trained physicians taking care of those patients.

I would also like to introduce the soon to be Wyoming ACEP President Dr. Steve Pecevich. Please join me in welcoming him and congratulating him on his new position!
